22 IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

25 To amend the Sustainable Solid Waste Management Amendment Act of 2014 to add specificity to
26 requirements for private collection properties including that they provide at least 32 gallons
27 of solid waste container space per residential unit and collection services twice per week
28 at minimum and adds a civil penalty or fine of no less than \$500 for repeat violations within
29 a 6-month period.

31 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
32 act may be cited as the "Containing Litter and Ensuring Adequate Neighborhood (CLEAN)
33 Collections Amendment Act of 2022".

34 Sec. 2. Title I of the Sustainable Solid Waste Management Amendment Act of 2014,
35 effective February 26, 2015 (D.C. Law 20-154; D.C. Official Code § 8-1031.01 *et seq.*), is
36 amended as follows:

37 (a) Section 104(a) (D.C. Official Code § 8-1031.04(a)) is amended by adding a new
38 paragraph (1A) to read as follows:

39 “(1A) Providing solid waste containers of sufficient capacity equivalent to 32
40 gallons of solid waste storage space per residential unit on the premises.”.

41 (b) A new section 105a is added to read as follows:

42 “Sec. 105a. Frequency of collection services at private collection properties.

43 “Collectors of solid waste from private collection properties shall provide solid waste
44 collection services twice per week at minimum at each property.”.

45 (c) Section 114 (D.C. Official Code § 8-1031.14) is amended as follows:

46 (1) Subsection (c) is amended as follows:

47 (A) Strike the period and insert the phrase “; provided, that:” in its place.

48 (B) New paragraphs (1) and (2) are added to read as follows:

49 “(1) A private collection property owner who fails to provide the equivalent of at
50 least 32 gallons of solid waste storage space per residential unit on the premises more than once
51 in a 6-month period shall be subject to a civil penalty or fine of no less than \$500; and

52 “(2) A collector of solid waste from a private collection property who fails to
53 provide twice-a-week service to a private collection property more than once in a 6-month period
54 shall be subject to a civil penalty or fine of no less than \$500.”.

55 Sec. 3. Fiscal impact statement.

56 The Council adopts the fiscal impact statement in the committee report as the fiscal
57 impact statement required by section 4aofthe General Legislative Procedures Act of 1975,
58 approved October 16, 2006 (120 Stat. 2038; D.C. Official Code§ 1-301.47a).

59 Sec. 4. Effective date.

60 This act shall take effect following approval by the Mayor (or in the event of veto by the
61 Mayor, action by the Council to override the veto), a 30-day period of congressional review as

62 provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
63 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
64 Columbia Register.
